7th/8th Grade League (grade in Fall 2019)
Separate divisions for Boys and Girls

To register for the league, **FULLY COMPLETE** the attached Team Roster (must have a minimum of 4 players) and **ALL** players' parents **MUST** sign a "Youth 3-on-3 Basketball League Release/Hold Harmless Agreement" form. The first 8 teams for each division completing registration will be in the league. Please submit your roster, waivers, and payment **EARLY** to insure a space in the league. You can also register online at <https://recregistration.wsprings.com>. If registering online, make sure to print out the additional documents (rules, roster and disclaimers).

Each team registering **MUST** have a team representative in attendance at this meeting. The purpose of the meeting is to: 1) meet and get acquainted; 2) go over the rules and regulations; and 3) get the league off to a good start.

The first 8 teams in each division completing registration will be in the league. Get registration in early. You do not have to wait until the league meeting to register but a representative must still be in attendance.

League Fee is \$120.00 per team. This includes indoor gym time, lockers (bring own lock/towel), timer/scorer, competition and champion tee shirts for the winning team. Players supply their own tee shirts for games.

At least 4 players must be entered on the roster before it will be accepted. Also, two team representatives must be listed on the top of the roster to receive phone messages and/or emails from the Recreation Department.

PLAYER ELIGIBILITY

Players must be in 7th/8th grade in Fall 2019. Teams may add additional players to roster until the 3rd game. No roster additions after the 3rd game. Coaches must inform the Recreation Department of any changes - this can be done by phone. The Recreation Department will be the holder of all team rosters and will make the changes as directed. New players must be added to the roster before they can participate.

GAMES AND SCHEDULE

Games will be played at the WS Recreation Center, 1500 Walker Street, WS. Games will be played on Monday nights 6:30, 7:30 or 8:30 pm (depending upon the schedule). Each team will play once a week.

There are showers and a locker room available for changing. Players must provide their own locks, towels and soap. The gym is air-conditioned.

The season is scheduled to begin June 17 and end August 5.

GENERAL

Please read the rules thoroughly. There are many little items in there that are spelled out to prevent mishaps. Bring your questions to the **League Organizational Meeting on Monday, June 10 at 6:00 pm.**

Please remind your players that they are guests of the facility and that they should behave in an appropriate manner.

This is a recreational league designed only for your enjoyment and socialization. Please remember that while there is competition, it is intended as only as a means to a fun end.

WESTERN SPRINGS RECREATION DEPARTMENT

Summer 7th & 8th Grade 3-on-3 League

(entering 7th/8th grade in the Fall)

1. Players must be in going into 7th/8th grade.
2. Teams must have 4 players on the roster to be eligible to participate. A maximum of 8 players is allowed on the roster.
3. Each team must wear like-colored shirts.
4. Games will be played at the WS Recreation Center on Monday evenings.. Game times will be 6:30-8:30 pm depending upon the number of teams and scheduling.
5. Each team must pay league fee with completed form.
6. Each game will consist of two 20-minute halves with a continuous running clock.
7. The clock will stop during the last 2 minutes of the game (and any OT) when out of bounds (but not after a basket) and on fouls. 5 minute half time.
8. Each team gets 3 timeouts per game. One timeout per OT period.
9. Games will be played on the cross courts at the WS Recreation Center Gym.
10. Players will call their own fouls. Only a timer/scorer will be provided.
11. Each score will be worth 2 or 3 points. Scorekeeper will rule on disputed 3-point shots.
12. Checked ball on all restarts/stoppage/substitutions.
13. Additional rules will be reviewed at the games (dead balls, misconduct, flagrant fouls, time wasting, etc.)
14. This is a summer recreation league for the players to have fun and further their basketball skills.
15. Timer will call flagrant fouls. A flagrant foul is one in which anybody tries to cause physical harm by going after the person and not the ball. A flagrant foul will result in the clock being stopped, two free throws awarded, and possession for the offended team.
16. During the last two minutes of each half, a 25 second rule on shots will be in effect. If a shot is not taken within 25 seconds a stalling the timer will call foul and possession will be turned over to the other team. A shot is defined as any attempt to put the ball in the basket whether or not it hits the rim.
17. If in the opinion of the timer the clock needs to stop for dead balls, misconduct, injury or other events, then they will whistle the game stopped.
18. No standings will be maintained.

GENERAL INFORMATION

19. The following rules are designed to insure that each participant has a good time. The Program Supervisor and Scorekeepers are staff members of the Recreation Dept and should be shown the same respect that you would expect. These people are there to help you enjoy the program.
20. New players must have their names added to the roster maintained at the Recreation Office before playing. Roster changes must be made between during normal office hours. Players may be added by calling the office and giving their names, address and phone number of the new player. A waiver can be signed at the games.
21. Poor conduct will not be tolerated. The Supervisor may at any time remove a player from the game for unsporting conduct.
22. If a player is ejected from a game, s/he must leave the gym. The league Supervisor will report the incident with the name of the player and their team to the Director of Recreation. Further incidents will be handled by standard Recreation Department policies and procedures.
